



EXECUTIVE SUMMARY

Background

The Participatory Plantation Forestry Programme (PFP 2) is a bilateral development aid programme established by the governments of Tanzania and Finland. It is the second phase of the Private Forestry Programme (PFP 1) and is designed to run from 1 November 2019 to 31 October 2023.

The programme increases rural income by promoting the commercial management of smallholder plantations and wood-processing enterprises. It adds value along the entire forest-product value chain, from improving the selection, quality, and vigour of planting material to introducing innovative, high-value wood products. It is also introducing and institutionalising vocational training in plantation forestry and wood-processing.

PFP 2 is set to operate in 3 town councils and 7 districts councils in three regions: Iringa (Mufindi district council, Mafinga town council and Kilolo district council), Njombe (Makete district council, Njombe town council, Njombe district council, Ludewa district council, Wang'ing'ombe district council and Makambako town council) and Ruvuma (Madaba district council). Within this overall area, the programme facilitates development of three potential forest industry clusters (Mafinga, Njombe and Makete forest industry clusters), each led by a Forest Industry Cluster Coordinator (FICC).

This quarter progress report covers the third quarter for the period from 1 January to 31 March 2021 of the second Tanzania's financial year of the Participatory Plantation Forestry Programme (PFP 2). This report follows the revised annual work plan (AWP) that was approved by the fourth programme steering committee meeting on 9 March 2021 and the result-based management framework (RBMF) that was approved in the original AWP on 14 July 2020.

Resources and Finance

For the reporting period, PFP 2 allocated a total budget of Euro 700,125. The total expenditure for the reporting period was Euro 571,389 equivalent to 81.61% of the allocated budget.

By the end of the reporting period, a total of Euro 1,757,019 had been spent by the programme for the 9 months period from 1 July 2020 to 31 March 2021. This was equivalent to 52.67% of the total allocated budget for the 2020/2021 AWP period.

Progress on tree out-growers support program

During the reporting period the silvicultural audit reports for KVTC and NFC were finalised and submitted to the Embassy of Finland in Dar es Salaam.

Planned activities

In the next quarter (April – June 2021), the programme will finalise the revision of the programme document and programme implementation manual (PIM). It is expected that, MoU with local government councils, MoUs for improved tree seed orchards/stands and MoU for VLUPs with NLUPC will be signed.

Overall, the programme will seek to achieve targets set for 2020/2021 period by the end of June 2021 as per the revised 2020/2021 AWP.

1. PROGRAMME DESCRIPTION

The Private Forestry Programme - PFP 1 (Now changed its name to Participatory Plantation Forestry Programme – PFP 2) started in January 2014. It was to run for four years, extended by one year to December 2018, and then further extended to 30 April 2019, by which time the original budget had been spent. The first phase was followed by a two-month bridging phase that required additional funding, which was provided by Forestry and Value Chains Development programme (FORVAC).

PFP 2 is a four-year continuation of the five-year and four-month PFP 1. It supports smallholder plantation forestry and wood-processing industries in the Southern Highlands of Tanzania. It started on 1 November 2019 and is expected to end on 31 October 2023.

Planning for PFP 2 commenced with formulation and appraisal missions conducted during October 2017 and May 2018, respectively. The draft PD that resulted from these consultant inputs was published by the Ministry for Foreign Affairs of Finland (MFA) on 15 May 2019.

The agreement between the government of Finland (GoF) and the government of Tanzania (GoT) on cooperating on PFP 2 was signed on 18 July 2019. GoT, through the Ministry of Finance and Planning (MoF) and Ministry of Natural Resources and Tourism (MNRT), and the GoF, through the MFA and the embassy of Finland in Tanzania, guided the mobilisation of resources and the practical arrangements needed to start implementing the programme immediately, beginning on 1 November 2019.

The overall objective of PFP 2 is the same as that of PFP 1: "To promote sustainable and inclusive private forestry that contributes to Tanzania's economic growth and alleviates poverty". PFP 2 aims to consolidate PFP 1's achievement by shifting from direct operations to facilitation, inclusiveness and the building of sustainability for a long-term impact.

To ensure that the plantation forestry sector in Tanzania is all-inclusive, PFP 2 was formulated with a human rights-based approach (HRBA), which, in practice means, the realisation of human rights as PFP 2 results. Furthermore, the PFP 2's HRBA approach will emphasise inclusive, participatory and non-discriminatory processes which are transparent and enhance accountability. PFP 2 strives to enhance the capacities of rights-holders, duty-bearers and, when relevant, other responsible actors. It has conducted a comprehensive human rights, gender, and vulnerability baseline assessment to facilitate the participation and inclusiveness of all programme stakeholders in implementation.

Studies conducted by both PFP 1 and the Forest Development Trust (FDT) over the last five years have improved understanding of the sector. Key findings include the following.

- a. Collectively, smallholders raise the largest area of forest plantations (>150,000 ha) of any producer in Tanzania and have the most scope for expansion.
- b. Collectively, SMEs produce the most sawn wood of any producer in Tanzania.
- c. Both smallholders and SMEs contribute greatly to livelihoods in the Southern Highlands, yet they are underserved in training, extension, infrastructure, financial services, research and innovation support, and, in consequence, do not achieve their potential.
- d. Forest value chains are based on too few tree species of unknown provenance. Both the FDT and PFP 1 have made major contributions to tree improvement, but these contributions are not sufficiently institutionalised.
- e. PFP 1 identified six potential forest industry clusters. The three with the most mediumterm development potential were Mafinga, Njombe and Makete. The forest industry clusters have many stakeholders, including smallholders and company and government growers; private transporters; non-government organisations (NGOs); and the ministries, departments and agencies of MoF, MNRT, Ministry of Education, Science and Technology (MoE), president's office regional administrational and local government (TAMISEMI) and VETA. However, since these stakeholders are not locally coordinated or optimised to work together, there are many inefficiencies in the sector, such as those listed below:

> Pine is planted when the market demands eucalyptus.

- The district governments of Mufindi, Mafinga, Kilolo, Makete, Njombe town council, Njombe district council, Ludewa, and Wang'ing'ombe are largely financed by taxing forestry, yet their reinvestment in commercial forestry extension is suboptimal
- > Impromptu taxes that cause businesses to fail are imposed.
- Sovernment land is left idle when it could be used productively.
- f. The most cost-effective way to reduce poverty through production forestry and sawmilling in the Southern Highlands is to improve forest industry cluster coordination and enhance the performances of both smallholders and SMEs.
- g. Makete District in Njombe Region has more smallholder plantation forestry than any other district, has some of the best growing conditions, and, until recently, has suffered from impoverishment due to its remoteness and lack of services. Rapid progress in rural electrification and road construction are, however, opening opportunities for rural industrialisation while at the same time improving market access.

PFP 2 focuses on cluster coordination and on groups of smallholders in plantation-rich villages where it believes it can have greatest impact on poverty reduction by improving plantation forestry and wood processing.

This report provides detailed information on the achievements and progress made during the third quarter of the 2020 – 2021 annual work plan (AWP) period. It covers the period from 1 January to 31 March 2021. The total MFA budget for the quarter period was Euro 700,125 where out of it, Euro 571,389 was the actual expenditure.

This report follows the revised annual work plan approved by the PSC on 9 March 2021 and result-based management framework (RBMF) endorsed by the PSC on 14 July 2020.

2. PROGRESS TOWARDS THE ACHIEVEMENT OF THE EXPECTED RESULTS

This section provides progress made for the outputs and activities targets set in the revised 2020/2021 AWP. Where appropriate the status of and progress made in each of the achieved targets are illustrated and rated as described in Table 2.1.

2.1 Broad programme management arrangements update

The AWP for the period from 1 July 2020 to 31 June 2021 was revised and approved by the PSC on 9 March 2021. It was agreed to report programme progress against this revised AWP but continue reporting against the original RBMF approved on 14 July 2020.

PFP 2 together with the local government authorities agreed to collaborate in implementing PFP 2 interventions in 80 villages as well as Makambako and Mafinga towns.

Overall, the programme is still implemented through a cluster-based approach in Mafinga, Njombe and Makete forest industry clusters with each led by a forest industry cluster coordinator.

1.1.1 Forestry cluster support to forest rich villages

80 villages selected and agreed with the local government authority for PFP 2 interventions. This includes 33 villages in Makete forest industry cluster, 23 in Mafinga forest industry cluster and 24 in Njombe forest industry cluster (Annex 2).

The PFP 2 memorandum of understanding with the local government authority (3 town and 7 district councils) drafted and approved by the PSC on 9 March 2021. The MoUs signing is expected to be implemented in the fourth quarter of the 2020/2021 AWP.

Through the participatory resource mapping and using the developed tools in open data kit (ODK), a total of 450 woodlots mapped in Makete forest industry cluster during the reporting period.

The "guideline for facilitation of tree growers' association establishment and strengthening" was published to the programme website. In March 2021, the programme organised and conducted 2 training events to district officials of 7 councils (Makete DC, Wanging'ombe DC, Makambako TC, Ludewa DC, Njombe TC, Njombe DC and Madaba DC) on facilitation of TGA establishment and strengthening.

No TGAs established during the reporting period although the programme-initiated hamlets and village level sensitization meetings to raise awareness on TGA establishment and strengthening. A total of 251 hamlets level TGA sensitization meetings were conducted in the three forest industry clusters (FIC): 200 Makete FIC, 14 Njombe FIC and 37 Mafinga FIC.

A total of 50 council extension officials allocated from the 10 councils to support programme implementations in the 80 PFP 2 selected villages (Table 2.2).

1.1.2 Capacity building to support TGA establishment

During the reporting period the TGA formation process was ongoing, and no trainings organised to TGAs on governance as per developed "guideline for facilitation of tree growers' association establishment and strengthening".

1.1.3 Forestry cluster development in Njombe and Mafinga

Overall, the Mafinga and Njombe forest industry cluster have been established and operational. 23 villages in Mafinga forest industry clusters and 24 villages in Njombe forest industry clusters were selected for PFP 2 interventions.

The forest industry cluster coordinators for Mafinga and Njombe managed to identify and collect preliminary information on TGA existence status in all PFP 2 selected village (Annex 2). By the reporting period the forest industry cluster coordinator completed village council meetings in these 47 PFP 2 selected villages to introduce the programme.

Terms of reference (ToRs) for consultancy to facilitate baseline studies in Njombe and Mafinga forest industry clusters approved by the fourth PSC. Arrangement and implementation of the baseline surveys to be initiated in the fourth quarter.

1.1.4 Support to PFP 1 TGAs

Discussions on drafted performance-based contract with TTGAU to support PFP 1 established TGAs progressed. Unfortunately, the contract had to be put on hold by the programme until completion of the tasks assigned to TTGAU in the previous contract issued in October 2020.

In the fourth quarter, programme planned to meet with TTGAU to discuss on best practical arrangement for collaborating in an efficient way. Overall, no progress being made on assessing the support to established TGAs during PFP 1.

1.1.5 Support to lead TGAs

The programme has initiated identifying leading TGAs in Makete forest industry cluster. The clusters currently, identified PFP 1 established TGAs in Ibaga, Ilindiwe, Mang'oto, Ihela and Mago villages to serve as demonstration TGAs to nearby TGAs. Overall, the lead TGAs identification will be implemented parallel to formation process.

1.2.1 Familiarizing village people, TGA leaders and facilitators

The programme continued to raise awareness and providing extension services in Makete forest industry cluster, on practical silvicultural operations and best operating practices in forest plantations management.

By the end of reporting period, 8 more demonstration plots established in 8 villages of Makete and Wanging'ombe districts. This makes a total of 27 demonstration plots altogether being established in Makete forest industry cluster.

Village level trainings on practical silvicultural operations and best operating practices in forest plantations management continued in the established demonstration plots (Figure 2.1).

Figure 2.1 Tree growers in Mafinga village at Wanging'ombe district being training in forest management activities.



In Njombe forest industry cluster the programme reached 43 influential leaders in 16 villages of three councils: Madaba, Ludewa and Njombe town councils. The composition included 32 village leaders (Village executive officers and chairpersons), 2 ward counsellors, 5 ward community development officers, 1 village agricultural forest officer and 3 district forest officers participated in awareness raising in 16 villages of Madaba, Ludewa and Njombe councils.

In Mafinga forest industry cluster the programme reached 151 hamlet and village leaders composed of 105 hamlet leaders, 23 village chairpersons and 23 village executive officers.

In the fourth quarter in Makete forest industry cluster, the programme planned to organise a dialogue workshop to bring together village leaders, TGA leaders and facilitators.

1.2.2 Training of tree growers, farmers and wood processors

In addition to the baseline studies conducted in Makete, the programme assessed training needs to all management units in Makete where, both, smallholders tree growers and SMEs were reached. During the fourth quarter training need assessment will progress in 10 villages of Wanging'ombe districts.

In Makete forest industry cluster training on occupation, safety and health initiated for tree growers and wood processors.

1.2.3 Field days and exchange visits

Field exchange visits planned to be organised and implemented between May and June 2021. By the reporting period no exchange visits and field days organised by the programme for TGAs or SMEs.

1.2.4 FWITC accreditation and registration

The programme continued to follow up on the FWITC land tenure issue. The fourth PSC agreed that the issue to be discussed by the competent authorities and the programme to continue renting the site up to June 2021.

By the reporting period, FWITC was already registered to business registration and licensing agency (BRELA) and the last inspection by VETA was scheduled to be conducted on 15 April 2021 for it to be accredited and registered.

On 13 March 2021, PFP 2 and FWITC were visited by the land, natural resources, and tourism parliamentary committee where the members of the committee were introduced to PFP 2 and FWITC. Also, the issue of FWITC land tenure was presented to the committee and was set to be discussed further between the committee and the minister of natural resources and tourism.

1.2.5 VETA 1-2-3 Forestry and Wood Processing curricula and training material development

The VET 1-2-3 forestry and wood processing curricula were accredited by VETA Tanzania in a board meeting held on February 2021.

In PFP 1, a total of 40 students received trainings on forestry and wood processing attendants' courses as pilot for VET 1-2-3 forestry and wood processing curricula. After these curricula being accredited, certificates collected from FTI and FITI to be issued to the respective students.

Arrangement for issuing these certificates to all 40 students is planned to be implemented in the fourth quarter of 2020/2021 AWP.

1.2.6 Compensation to tree growers

Under the "do-no-harm" principle we are obliged to compensate for damage done during the PFP 1 as a continuation programme. Upon need assessment to tree growers received seedlings that were affected by "Pitch canker" the programme will compensate.

It was already too late for this planting season, but upon needs, arrangement will be made in the future.

1.2.7 Assessment of employment opportunities

The study was completed in Makete forest industry cluster and is to be extended to Mafinga and Njombe forest industry clusters.

By the reporting period, ToRs for facilitation of baseline surveys in Mafinga and Njombe forest industry clusters were already being approved for further action by the programme. The implementation of the baseline is expected to be initiated in the fourth quarter of the 2020/2021 AWP.

1.2.8 Internship programme to expand service provisions

Assessment of the PFP 1 facilitators is to be implemented during the fourth quarter including arrangement for executing it.

The programme-initiated plans to recruit an intern on information technology to assist in developing the forestry and market information systems.

The plan is to be executed upon completion of the system specification requirement in which by the reporting period it was on progress.

1.2.9 TGA tree orchards management

PFP 2, TFS and TTGAU continued to collaborate in development of programme supported seed orchards and stands.

A 3-days stakeholders' workshop was organised by PFP 2 to agree and develop MoUs for improved tree seed production. The workshop was conducted from 17 to 19 February 2021 including PFP 2, TGAs representatives, TTGAU, MNRT, FWITC and Mbinga council.

The drafted MoUs for improved tree seed production were submitted and approved by the fourth PSC held on 9 March 2021. By the reporting period the MoUs were not yet signed.

During the reporting period, the programme facilitated completion of thinning operation on seed stands located in idete/Holo village and Makungu village close to Mufindi paper mill (MPM). Thinning activities involved marking, felling of marked trees and removal of brushwood out of stands.

The programme through TTGAU facilitated various management activities in programme supported TGA based seed orchards. In Maweso, Ibumi, Njelela, Ifinga and Utiri seed orchards established in 2018, marking within replications and tagging performed.

The seed orchards/stands signage designed, and stakeholder's information updated to include stakeholders contacts, and names. The signages are expected to be completed in the next fourth quarter of the 2020/2021 AWP.

During the reporting period the programme incorporated comments provided during the third PSC meeting (held on 3 December 2020) and published the first version of the "Improved tree seed production manual". This manual will guide development of the detailed management plans for each programme facilitated seed orchards and stands that is to be implemented in the next 2021/2022 AWP.

1.2.10 Support in woodlot management planning

During the reporting period, preliminary information for 450 woodlots collected for development of forest management plans for smallholders' tree growers' woodlots. The data were collected in a participatory approach including smallholders tree growers.

This preliminary information included ownership, forestry variables and spatial information. The aim is to help smallholders tree growers developing simple woodlot management plan to guide and develop their woodlot based on the recommended silvicultural operations and best operational practices.

The information collected in woodlots of 15 to 20 smallholders tree growers in all 33 villages in Makete forest industry clusters, who are potential to be part of TGA member during TGA formation so that they can start realizing the potentiality and profitability in forestry investment.

1.4.1 Establish landscape level land use planning model

During the reporting period, no progress made on supporting Sokoine University of Agriculture (SUA) and Tanzania forest services (TFS) in implementing the integrated fire management guidelines in Ifinga, Ruvuma. The plan is to initiate discussion with SUA and TFS on the aspect during the fourth quarter with a possibility to introduce the landscape level planning in Makete forest industry cluster.

The programme planned to provide fire management training to participatory land use management teams and village fire management groups in the fourth quarter when development of village land use plan will be initiated. Also, TGA, Village and District bylaws will be reviewed to ensure they include for the exigencies of fire risk management and penalties for offenders.

1.4.2 Extension services to prevent forest fires

The programme has started awareness raising on forest fire prevention in 33 villages in Makete forest industry clusters. The forest fires prevention has been incorporated in all awareness raising events to initiate plans for further trainings.

During the Njombe and Makete forest clusters inception workshop, the Njombe-regional fire and rescue force raised awareness on forest fire prevention to stakeholders including tree growers. Further discussion on opportunity for collaboration initiated at cluster level.

In the next fourth quarter of 2020/2021 AWP the programme is planning to execute fire management training courses in 40 PFP 2 villages. The plan is to involve District Officials, PFP 2 Extension staffs, tree growers, influencers, TFS and Regional Fire and Rescue Force.

1.5.1 Disseminate objectives and outcomes of PFP 2

On 9 March 2021, the programme conducted its fourth programme steering committee meeting, that was the third PSC in the current AWP period. Furthermore, the supervisory board meeting was scheduled to be conducted in either May or June 2021.

The programme management team planned to complete revision of the programme document (PD) in the end of April 2021 and initiate the approval process including quality assurance.

The ToRs for communication service provision were approved by the competent authorities and the fourth PSC in March 2021. The service provision that also includes facilitation to develop programme communication strategy is expected to materialise during the fourth quarter of the 2020/2021 AWP.

In reference to output 1.6, to ensure the local government and other stakeholders involved in the current PFP 2 AWPs, understand the rationale for PFP 2 and are knowledgeable of its activities, PFP 2 implemented two (2) major workshops: Njombe regional inception workshop and a participatory regional and district planning workshop. Further description of the composition please refer to output 1.6.

1.5.2 Establish platform for regular meetings with stakeholders

During the reporting period, the Makete and Mafinga forest industry cluster coordinators have attended several council management team's meetings. Also, the programme has been invited to participate in Ruvuma Forest development workshop on 29 and 30 April 2021 and participate in improving the Njombe investment plan that is to be shared on 16 March 2021.

As a development aid to strengthen smallholders tree growers and SMEs including their associations, being invited to these types of meetings and interventions, initiate efforts towards ensuring TGAs have regular meetings with local government and SMEs.

The programme established quarter reporting meeting to ensure progress communication among stakeholders. In this reporting period the meeting was conducted from 18 to 22 January 2021. Stakeholders as part of programme implementation collaborate in reporting progress related to programme interventions in these quarterly reporting meetings.

1.5.3 Maintaining PFP website

A total of 2,761 visitors (Cumulative unique visitors recorded monthly) and 596 downloads recorded for the period from 1 January to 31 March 2021. Overall, the programme website's visitors are coming from over 25 countries around the world including Tanzania and Finland.

By the end of the reporting period, a total of 56,932 hits recorded navigating in 23,668 pages and requesting downloads from the programme website.

Overall, the programme website's activities increase monthly (Table 2.3). Panda Miti Kibiashara was the most searched word for accessing the programme website. This is attributed by intensifying contents upload in both; programme's website and social media pages such as Facebook, Instagram, and LinkedIn that all direct visitors to the programme website.

1.5.4 Establishment of Forest and Market Information Systems

The programme-initiated development of FMIS and MaIS system requirement specification that will act as a benchmark report for designing the FMIS and MaIS. Tentative plan to be implemented in the fourth quarter is to recruit an intern knowledgeable on information technology to assist in the design process including data management and processing.

During the reporting period, continuously collected data on smallholders' woodlots plantations and SMEs are cleaned and edited. Discussion to redesign the existed forest information system in PFP 1 initiated, although much work will be conducted in the fourth quarter.

The "Makete Forest Resource Market Systems Assessment" was completed and published to the programme website. Furthermore, the study will be extended to other programme areas including Mafinga and Njombe forest industry clusters.

The programme did incorporate the information sharing aspect on forest value chain actors in various workshops organised by the programme in 3 PFP 2 forest industry clusters including the Njombe regional forest inception workshop that combined Njombe and Makete forest industry clusters.

1.6.1 Integration of PFP activities in district work plans

On 28 and 29 January 2021 the programme organised and conducted a two days Njombe regional inception workshop including various stakeholders from Njombe and Makete forest industry clusters. Over 180 participants received the opportunity to participate in the event and discussing various issues related to forest sector.

The Njombe regional commissioner was the guest of honour although he was represented by the Njombe district commissioner. Also, district commissioners and districts/towns executive directors from 7 councils (Ludewa, Makete, Makambako, Wanging'ombe, Madaba, Njombe town and Njombe district) participated. Other stakeholders include tree growers, various categories of SMEs, TTGAU, TFS, Njombe regional fire unit force, TGAs, SUA, VETA and other institutions.

From 1 to 5 February 2021, the programme conducted a participatory planning workshop with 10 PFP 2 councils to agree on collaborating in programme implementation and drafting MoUs with each council.

District commissioners, districts/town executive directors and other districts/towns councils' officials participated in the planning meeting. Together we agreed to collaborate in programme implementation activities including integrating PFP activities in district work plans. As an achievement of the workshop, MoUs with local government for collaborating in implementation of PFP 2 interventions was drafted and approved by the fourth PSC meeting on 9 March 2021. Overall, the signing of the MoUs will be conducted in the fourth guarter of 2020/2021 AWP.

From 8 to 19 March PFP 2 forest industry cluster coordinators with council officials collaborated to come up with a plan including budget and district human resources allocation for PFP 2 implementation. The plans were presented to the fourth PSC and it was agreed to incorporate it to the revised programme document and 2021/2022 AWP.

1.6.2 Facilitate issuing of CCROs to households

By the reporting period, the district staffs were not trained on MAST technology for issuing CCROs and no CCROs issued. The main reason being, the founder and developer of Mobile Application to Secure Tenure (MAST) technology, the Land Tenure Assistant (LTA) is phasing out by the end of 2021 and were occupied with field assessment for phasing out during this third quarter hence it was difficult to collaborate in issuing training on MAST technology to district officials as planned.

During the reporting period, the programme continued to communicate with LTA organisation based in Iringa to follow up and schedule training for district staff on MAST that is expected to materialise during the next fourth quarter of 2020/2021 AWP.

PFP 2 in collaboration with district officials in programme area have started gathering information on CCROs issued and training conducted on MAST. This is to avoid duplication and assessing the possibility of continuing facilitating issuing CCROs in PFP 2 villages where the district staffs were already trained.

1.6.3 Define criteria for new VLUPs and facilitate preparation

The PFP 2 memorandum of understanding (MoU) with the National Land Use Planning Commission (NLUPC) to collaborate in facilitating preparation of Village Land Use Plan (VLUP) was approved by the PSC on 9 March 2021.

On 17 March 2021, after incorporating comments from the PSC, the MoU was sent to the NLUPC for further actions. By the reporting period the MoU was not yet signed and delays mayorly caused by change of leadership in the NLUPC. Follow up are on progress in communicating with NLUPC for signing the MoU.

By the reporting period, the programme-initiated collection of preliminary information on status of village land use plans in all 80 PFP 2 selected (Annex 2).

1.6.4 Study on vulnerability inclusiveness

The human rights and gender situational assessment report that includes households progress out of poverty index (PPI) score survey was approved by the competent authority and published to the programme website. The study developed vulnerability definition that aligns with PFP 2 interventions.

The application of the developed vulnerability definition for the identification of vulnerable groups in various PFP 2 activities will be implemented in considerations of the comments provided during the fourth PSC meeting that was conducted on 9 March 2021.

By the reporting period, terms of reference (ToR) for conducting a human rights and gender situation assessment for Njombe and Mafinga forest industry clusters developed, approved, and advertised for open tendering.

The programme refined tools for recording participants in various PFP 2 interventions to ensure inclusiveness of vulnerable groups into PFP 2 AWP 2021/22 guaranteed with clear participation. The participation in PFP 2 activities is disaggregated by gender, age, vulnerability and ability.

In reference to this collected information, a total of 2,704 vulnerable people reached in the third quarter, who are more likely or liable to face severe obstacles in enjoying equal benefits.

1.6.5 Define investment profiles for plantation establishment

Due to changes of plan and in reference to the revised AWP, this intervention will be implemented in the next 2021/2022 AWP.

2.1.1 FWITC development and training provision

To ensure sustainability of FWITC, on 27 January 2021, the proposal for FWITC to secure Euro 437,037 from the European Union Transition (EUT) was submitted. By the reporting period the evaluation process was on progress and feedback is expected to be in June 2021 onwards.

The procured items for the mobile training unit arrived in Tanzania on 12 March 2021 and berthed on 25 March 2021 at the port and clearance processes were initiated. Unfortunately, the value added tax (VAT) exemption was rejected for two main reasons:

- The VAT exemption application forms have changed and require filling of the newly updated application forms.
- The procurement items not being in gazettement notice which is to be attached as a requirement of newly updated VAT exemption application forms.

The programme filled the newly updated VAT exemption application forms and submitted to MNRT for further actions. By the reporting period follow up was still on progress.

On March 2021, 40 SMEs from Mafinga forest industry cluster received training on sawmilling management, production records keeping and appreciation of improved recovery and profitability.

10 members of the Tree growers association (TGA) at Nundwi villages were training on soilless tree nursery establishment and management at FWITC.

2.1.2 Support to FWITC

PFP 2 continued to support FWITC despite the unresolved land tenure issue. On February 2021 minister of natural resource and tourism visited the site and on 13 March 2021 the land, natural resources and tourism parliamentary committee visited FWITC. Overall, by the reporting period the discussion to procure the site was on progress.

FWITC progressed to engage in income generating activities and trainings related to nursery, joinery and carpentry, timber drying and saw doctoring. The nursery sold 43,000 *E. urograndis* seedlings.

2.1.3 Demonstration of appropriate forestry and wood processing technologies

During January 2021, the programme conducted a training need assessment (TNA) to SMEs in 23 PFP 2 villages in Makete. This was a further assessment in addition to finding from the baseline studies conducted during the second quarter.

In all three PFP 2 forest industry clusters, the demonstration of appropriate forestry and wood processing technologies in the selected PFP 2 villages is to be implemented during the fourth quarter of 2020/2021 AWP.

A sustainable charcoal and briquette production demonstration training was conducted on 16 March 2021. A total of 45 participants: 6 male and 39 female received theory and practical demonstrational training on charcoal and briquette productions.

In reference to findings of the baseline studies and the training needs assessment of ding dong SMEs, the Occupation Safety and Health training were conducted in 3 villages (Ihela, Lupalilo and Kising'a) for 35 ding dong owners.

2.1.4 Encourage participation of women, youth, and vulnerable groups




Figure 2.2 Participation of women and vulnerable groups in PFP 2 activities in Mafinga, Makete and Njombe forest industry clusters.

The programme continued to raise awareness to encourage women, youth and other vulnerable groups participation. For the period of January to March 2021, the programme managed to reach TASAF registered beneficiaries, youth and women groups more likely or liable to face limitations in accessing forest opportunities including limited access to land for women in PFP 2 villages (Figure 2.2).

Furthermore, in the fourth quarter, the programme planned to organise the "women in forestry roundtable" dialogue platform in each PFP 2 forest industry clusters to bring together women in forestry in the southern highlands of Tanzania for networking opportunities, exposure visits, mentorship and experience sharing events.

The event will involve awareness activities such as media tour; networking activities, discussions workshop, mentorship activities, exchange visit as well as showcasing wood business product and activities done by women. Women can be connected through online platform as well to keep them connected.

To encourage women participation and investment in forest sector, 15 women SMEs groups involving a total of 150 members in Mafinga forest industry clusters reached during the reporting period.

2.1.5 Awareness raising of SMEs in company responsibilities

By the reporting period, a leaflet on HRBA aspect was not yet prepared and planned to be implemented in the fourth quarter. In Mafinga forest industry cluster, 80 SMEs in 8 different villages reached in awareness raising of related to company responsibilities.

Overall, in all 3 PFP 2 forest industry clusters' extension services awareness raising events on the aspect of HRBA has been discussed.

2.3.2 Output 2.2. Increased access of SMEs to financing

2.2.1 Support SMEs in preparing business plans

During the reporting period, the programme assessed and mapped 769 forestry SMEs and larger entrepreneurship businesses in Mafinga forest industry cluster. This includes 236 SMEs, 76 forestry processing industries and 378 harvesting and sawmilling operations (Table 2.4).

On 9 March 2021, the SME service provision contract was approved by the fourth PSC that includes facilitation of SMEs in preparing business plans. Implementation of the SME service provision contract is expected to materialise during the fourth guarter of the 2020/2021 AWP.

In February 2021, 25 carpenters in wood joinery and carpentry and 15 small timber yards business owners in Mafinga forest industry cluster received sensitisation training on business management, business plan, record keeping and access to finances.

During the reporting period, the programme facilitated 25 SMEs in wood joinery and carpentry in establishing an association of furniture and carpenters in Mafinga forest industry cluster. This is to promote innovative business ideas and models.

By the reporting period, the leapfrog company on afri-furniture project completed baseline assessment for wood furniture and the report is to be finalised during the fourth quarter for further actions including conducting their second steering committee meeting which is scheduled to be implemented in 12 April 2021.

2.2.2 Linking SMEs and financial institutions

Through the programme organised Njombe regional inception workshop, SMEs were linked with financial institutions to increase access of SMEs to financing. No formal regular platform established for linking SMEs and financial institutions.

2.2.3 Supporting SMEs in sourcing global investment funds

No target for the 2020/2021 annual work plan period.

2.3.1 Development and deployment of log and sawn timber grading

Through government notice (GN) number 882, the "TZS 387:2020 Timber-strength of coniferous sawn timber (cypress and pine) for structural use" and "TZS 256-1:1:2020 Timber-dimensions for coniferous sawn timber (cypress and pine)" were gazetted and published in October 2020.

Currently TFS is on top in enforcing the structural sawn timber grading rules. Stakeholders' awareness raised during the Njombe regional inception workshop and the participatory district planning workshop.

During the reporting period, follow up on enforcement of the published log and sawn timber sorting and grading rules progress including discussion with various actors including TFS.

2.3.2 Support wood industry sector for sustainable raw material procurement

Through the PFP 2 organised Njombe regional inception workshop, the private and public tree growers, TTGAU and TGAs integrated with SMEs wood processors. The sustainable supply and demand of forestry raw materials discussed.

A recommendation was given for having regular platforms at regional or cluster level that will integrate the private and public tree growers, TTGAU and TGAs integrated with SMEs wood processors.

2.3.3 Development of appropriate forest and wood processing technologies

In reference to section 2.3.1 under sub section "2.1.1 FWITC development and training provision", the equipment for the mobile training units arrived in Tanzania including 2 times 40" second-hand containers and processes on VAT exemption and clearance were on progress.

The establishment of improved ding dong model with improved production operations for training and demonstrations will be implemented during the fourth quarter of 2020/2021 AWP.

2.3.4 Product development and improved use of wood waste

Implementation of the afri-furniture project continued and during the reporting period, the leapfrog company team visited the southern highland to complete collecting baseline information for finalising the progress and ethnography report of the furniture value chain in the southern highland and Tanzania in general. Finalisation of the report is set to be in the fourth quarter of the programme implementation.

One of the biggest challenges in sustainability of charcoal and briquetting production is availability of spare parts of machines. During the reporting period, the programme in collaboration with SCABPU met Tanzania Automotive Technology Centre (TATC) Nyumbu in Morogoro on possibility to manufacture spare parts for sustainable charcoal and briquetting.

2.4.1 Awareness raising in utilization of forest and wood products

The programme continued to promote Wood products and wood utilisation in Tanzania households through various PFP 2 organised events (including invited events), trainings and extension services.

The idea of developing fixed and mobile show rooms where forest and wood products and wood utilisation could be shown to public was postponed in this 2020/2021 annual work plan period due to limited practical arrangements and low relevance in the current situation.

During the reporting period, the service provision contract incorporating development of the SMEs business development and association establishment guideline was approved for further action. The implementation of the contract is expected to materialise in the fourth quarter of the 2020/2021 AWP.

2.4.2 Accomplish and synchronize FMIS and MalS

Due to change of plans to accomplish baseline studies in Mafinga and Njombe forest industry clusters, some progress might be initiated on FMIS and MaIS, although the programme will implement this activity in the next 2021/2022 AWP.

2.4.3 Dissemination of FMIS and MaIS

Due to change of plans to accomplish baseline studies in Mafinga and Njombe forest industry clusters, some progress might be initiated on FMIS and MaIS, although the programme will implement this activity in the next 2021/2022 AWP.

2.4.4 PFP forest industry cluster development

The programme continued to raise awareness on the forest industry cluster development approach. All programme staffs were trained and facilitated for forest industry cluster development during the first and second quarter of 2020/2021 AWP period. This is to ensure that the concept is well known for easy communication and awareness raising to the stakeholders and beneficiary of the programme.

Discussions for PFP 2 to facilitate establishment of timber yards in three forest industry clusters initiated but expected to materialise and being included in the next 2021/2022 annual work plan.

2.5.1 Facilitation of dialogue and liaison platform

The PFP 2 organised Njombe regional inception workshop and the participatory district planning workshop to share information to regional and district authorities on forest and wood industry development.

The programme through three forest industry cluster coordinators managed to secure participation and involvement in council management teams meeting that also allow sharing of information to local government authorities on forest and wood industry development.

During the reporting period the programme-initiated discussions with regional and district authorities, on the current level of district investment in forestry and wood industries extension and business environment improvement; and how this investment might be optimised.

By the reporting period, CESS data collected in all 10 councils including forestry budget in previous and the current fiscal financial year. The position paper was drafted to evaluate the current level of district investment in forestry and wood industries extension and business environment improvement; and how this investment might be optimised.

During the fourth quarter of the 2020/2021 AWP, the programme will organise validation workshop with regional and district authorities to present findings of the study and agree for further actions.

2.5.2 Association development in wood industry sector

The programme-initiated discussions with SHIVIMITA on best options for collaborating and integrating PFP 2 activities as well as supporting SMEs associations. Tentatively, the PFP 2 and SHIVIMITA agrees on collaborating through a performance-based contract. In Mafinga forest industry cluster, SAFIA and UWASA were met as well during the reporting period.

The programme still sees the importance of strengthening SHIVIMITA to the extent of TTGAU ensuring that it operates independently as an umbrella for SMEs associations in Tanzania.

Also, the programme continued to communicate and collaborate closely with SCABPU to promote development on sustainable charcoal and briquetting production. In January 2021,

programme supported various stakeholders including SCABPU and FWITC to write proposal to EUT to secure fund of more than Euro 500,000.

2.5.3 Facilitation and enforcement of HRBAs in PFP 2 implementation

The PFP 2 staff training on HRBA aspect during the first quarter of the 2020/2021 annual work plan period to ensure all staff members understand the importance of these issues in their day-to-day work.

The programme continued to ensure and promote the rights and obligations of workers and whenever PFP 2 staff will be involved in programme interventions to encourage and co-operate with local government authorities to enforce existing forestry work and employment regulation.

Also, the programme continued to monitor and follow workers' skills training provided to include occupation, safety and health issues as part of the training programme.

3.2.1 Programme Document revised and approved

The revision of the programme document is set to be implemented during April 2021 for endorsement in the fifth PSC and approval by the first programme supervisory board.

The programme continued to collect and receive baseline information from secondary sources including related to CESS collections. To ensure timely collection of such information, the programme has already drafted MoU with local government authorities.

During the reporting period, the ToRs for short term national and international consultancy for implementing and extending baseline studies to Mafinga and Njombe forest industry clusters were approved by the fourth competent authorities and PSC.

3.2.2 Familiarization of programme management team and stakeholders

The programme management team and stakeholders are familiar of PFP 2 including outcomes and interventions. The programme has continuously been engaging stakeholders in various activities to ensure inclusivity of all social groups including vulnerable people.

3.2.3 Development of MoUs with districts and partners

The memorandum of understanding (MoU) with the National Land Use Planning Commission (NLUPC) was approved by the competent authorities on the fourth PSC. The MoU was submitted to the NLUPC for further actions and expected to materialise during the fourth quarter of the 2020/2021 AWP.

Through the participatory district planning workshop, the programme together with the 10 councils under supervision of a lawyer from MNRT drafted 10 MoU with the local government authority for the implementation of PFP 2 in 80 selected villages of the 10 councils. The drafted MoUs were approved by the fourth PSC and expected to be signed during the fourth quarter of the 2020/2021 AWP.

Through the improved tree see production stakeholders workshop conducted from 17 to 19 February 2021, the programme managed to facilitate development of the two (2) improved tree seed production master MoUs with key stakeholders to collaborate in supervision and management of the PFP supported seed orchards and stands.

3.2.4 Establishment of annual service provision contracts

Follow up progressed on the contract for the funds issued to TTGAU during the second quarter of the 2020/2021 AWP. By the end of the reporting period TTGAU was still progressing with implementing activities agree in the contract issued during the second quarter of the 2020/2021 AWP.

Also, the programme managed to draft terms of reference for communication service provision contract. The terms of reference were approved in March 2021 by the competent authorities. By the reporting period it was already advertised for open tendering and expected to materialise in the fourth quarter of the 2020/2021 AWP.

3.2.5 Development of PFP 2 communication strategy

Through the advertised communication service provision contract, the service provider will also facilitate development of the PFP 2 communication strategy.

3.2.6 Development of monitoring and evaluation plan for PFP 2

The monitoring and evaluation plan drafted and to be finalized after the revised RBMF and PD have been approved.

2.5 Auditing MFA out growers support programme

MFA through embassy of Finland in Dar es salaam, appointed PFP 2 to evaluated and audit the tree out grower's support program (TOSP) provided by MFA through Tanzania Tree Growers Association Union (TTGAU), New Forest Company (NFC) and Kilombero Valley Teak Company (KVTC).

During the reporting period, the NFC and KVTC silvicultural audit reports for 2019/2020 planting season was completed and submitted to the embassy of Finland in Dar es salaam for further actions.

Overall, a total of 40 woodlots and 109 woodlots surveyed for KVTC and NFC respectively.

3. DEVIATIONS FROM THE WORK PLAN AND CORRECTIVE MEASURES

Because of the delays in revising the programme document and collecting baseline data it was only possible to establish annual rather than quarterly targets for the 2020/2021 AWP. For this reason, quarterly achievements appear to be under achievements because they only relate to part of the overall planning period.

There were some instances such as in organisation of field days and exchange visits, evaluation of existing VSLA/VICOBA, establishment of landscape level land use planning and training of saw doctors where progress appears to be particularly poor, but the programme will catch up with these activities in the fourth quarter.

4. RESOURCES AND BUDGET

4.1 Finance




Figure 4.1 Brief summary of the third quarter expenditure versus the budget

The overall budget of the programme for the reporting period was Euro 700,125 and the actual expenditure was Euro 571,389 equivalent to 81.61% expenditure. Figure 4.1 compares the expenditure for the third quarters against the annual budget set.

Table 4.1 provides comparison of the budget and actual expenditure for the period of nine months (From 1 July 2020 to 31 March 2021). On the other hand, Table 4.2 is the detailed summary of the expenditure with respect to budget for the third quarter (1 January to 31 March 2021).

4.2 Reasons for over and under expenditure

Under output 1.6 the over expenditure occurred because of a surge in workshop activities, and this will be balanced out in the next fourth quarter. This included the Njombe regional inception workshop and the participatory district planning workshop. The demobilisation of the IFPPE at the beginning of the COVID-19 pandemic and his unwillingness to return contributed to the under expenditure on TA.

Some apparent under expenditures relate to activities for which expenditures will only be incurred in the fourth quarter.

4.3 Technical assistance

By the reporting period, the total number of days from July 2020 to March 2021 consumed for technical assistance works were 969 days. The total number of days allocated for technical assistance for the 2020/2021 annual work plan period is 1,250 days. Theoretically, 77.52% of the total man days allocated for technical assistance consumed for various programme interventions.

4.4 Human resource update

Sadly, the FICC for Njombe resigned and after discussion with competent authorities Mahendeka Jeremiah who was a well experienced extension officer was promoted to be acting cluster coordinator. This created a deficiency in the programme extension capability and so Gaston Masalu who was previously interviewed and considered to be well qualified was recruited.

4.5 Procurement update

By 31 March 2021, the status of procurement in relation to that planned budget in the AWP was as shown in Annex 1.

5. ASSUMPTIONS AND RISKS

5.1 Assumptions

No changes of the assumption statements for each result chain component. The assumptions remained as presented in the RBMF of the 2020/2021 AWP report endorsed by the PSC on 9 March 2021.

5.2 Risk assessment and mitigation of the risk

5.2.1 Programme document identified risks

Analysis of the key risk related to the implementation of the programme and the proposed mitigation strategies remained as presented in the in the 2020/2021 annual work plan endorsed by the fourth PSC conducted on 9 March 2021.

Furthermore, significant changes and assessment to the risk identified expected to be analysed during the fourth quarter in annual progress report of the 2020/2021 AWP. This aligns with the instruction from the manual for bilateral programmes under section on risk management (page 21 on monitoring of the risks).

5.2.2 Programme emerging risks

By the reporting period the programme was declared VAT exempted. Although another issue raised on procedures to be exempted for procurement which caused delays and limited clearance of the equipment for the mobile training unit. The most limiting criteria/condition being for procurement plan needed to be advertised in the government notice (GN) and a GN including its reference number to be attached in the VAT exemption application forms. The programme filled the newly updated VAT exemption application forms and submitted to MNRT. By the reporting period follow up was on progress.

The unresolved FWITC security land tenure is continuously limiting and causing delays of programme supports related to FWITC. Currently, through the fourth PSC meeting it was agree to be discussed at competent authority level and feedback to be given to the programme. By the reporting period the issue was still not resolved.

The risk assessment for the threat posed by avocado plantation in forest sector and the progress of the risk observed emerged risks during the first quarter are presented in Table 5.1. Apart from the issue of avocado, no emerging risks observed during the second quarter period.
